## A Characterization of the Catenoid'

1. The present paper is concerned with doubly-connected minimal surfaces S in a slab  $c_1 < z < c_2$  of (x, y, z)-space  $(-\infty \le c_1 < c_2 \le \infty)$  (i.e. mappings into the slab from an annulus of the parameter plane) which have the property that their intersections  $S_c$  with every plane z = c, for  $c_1 < c < c_2$ , are Jordan curves. There exist a few explicit examples, especially the catenoid (by which we mean here, as always, the complete catenoid) which appears as a particular case of the minimal surfaces determined by A. Enneper [1] and B. Riemann [7] (see Figure 1):

(1) 
$$x(u, v) = \alpha_0 + \alpha m(u) + u \cos v,$$

$$y(u, v) = \beta_0 + \beta m(u) + u \sin v,$$

$$z(u, v) = \gamma_0 + \int_{u_0}^{u} \frac{dw}{\Delta(w)}$$

where  $-\infty < u < \infty$ ,  $0 \le v < 2\pi$ .

Here

$$m(u) = \int_{u_0}^{u} \frac{w^2 dw}{\Delta(w)}, \qquad \Delta(w) = \sqrt{(\alpha^2 + \beta^2)w^4 + 2\gamma w^2 - 1},$$

and  $u_0$  may be taken as  $u_0 = \sqrt{(\delta - \gamma)/(\alpha^2 + \beta^2)}$  where  $\delta = \sqrt{\alpha^2 + \beta^2 + \gamma^2}$ . If  $\alpha = \beta = 0$  (the case of the catenoid) then  $\gamma$  must be positive and  $u_0 = 1/\sqrt{2\gamma}$ . The integrals can be expressed in terms of elliptic integrals of the first and second kind. The intersections  $S_c$  with planes z = c are circles and, except for the catenoid,  $c_1$  and  $c_2$  are finite:

$$c_1 = \gamma_0 - \frac{1}{\sqrt{2\delta}} K(k), \quad c_2 = \gamma_0 + \frac{1}{\sqrt{2\delta}} K(k); \quad k = \sqrt{\frac{1}{2} \left(1 + \frac{\gamma}{\delta}\right)}.$$

K(k) and E(k) denote the complete elliptic integrals of the first and second kind with modulus k.

Further examples for such doubly-connected minimal surfaces are secured
