Positive Operators on the Disk Algebra

Let A denote the disk algebra equipped with the sup-norm. All operators considered here are bounded linear operators from A to A: Let P denote the set of operators having norm 1 which carry the constant function 1 into itself. It is not hard to show that an operator T is in P iff T1 = 1 and T is positive, i.e., Re $f \ge 0$ implies Re $Tf \ge 0$. In this paper we study the extremal structure of the convex set P. We are particularly interested in subsets of P of the form $K(F, G) = \{T \in P | TF = G\}$, where F and G are members of the closed unit ball U of A. If G is an extreme point of U, then K(F, G) is an extreme subset of P, i.e., T_1 , $T_2 \in P$, $c \in (0, 1)$ and c T + (1 - c) $T_2 \in K(F, G)$ implies $T_1, T_2 \in K(F, G)$. Thus, any extreme element of K(F, G) will be an extreme element of P. It will be convenient to consider three classes \mathcal{I} , E_0 , E_1 , of extreme elements of U where \mathcal{I} denotes the collection of non-constant inner functions, E_0 denotes the collection of non-constant exposed points of U, and E_1 denotes the collection of non-constant extreme points of U. If F and G are in \mathcal{I} , then the dimension of K(F, G) is finite and can be calculated. (See [2], [7].) In Section 1 we show that if G is in \mathcal{I} and is non-constant, then $K(F, G) \neq \emptyset$ iff $F \in \mathcal{I}$. We also show that, for i = 0, 1, if G is in E_i and $K(F, G) \neq \emptyset$, then $F \in E_i$. Furthermore, our methods lead to the proof of a conjecture of Rochberg [7]. In Section 2 we outline a method which can be used to analyze the structure of K(F, G) in cases where F and G are both inner. We also illustrate our method by applying it to the following special cases: F inner and G = Z, where Z is the identity on the closed unit disk \bar{D} , and $F = Z^2$ and $G = Z^2$.

Section 1. $K(F, G) \neq \emptyset$ and $G \in \mathcal{I}(E_i)$ implies $F \in \mathcal{I}(E_i)$. For $f \in A$ we will use Pf to denote the *orbit* of f under the action of P, i.e., $Pf = \{Tf | T \in P\}$. The uniform closure of Pf will be denoted by clPf. The notion of orbit was introduced in a similar context by Ryff [9].

Theorem 1.1. Suppose $F \in U$. If clPf contains a non-constant inner function, then F is inner.
