## Lorentz Space Forms and Virtually Solvable Groups

In this paper we shall study the structure of Lorentz space forms whose fundamental groups are virtually solvable. Let V denote a vector space of real (n + 2)-tuples  $v = (x_1, x_2, y_1, \ldots, y_n)$  with a nondegenerate quadratic form

$$Q(v) = -x_1^2 - x_2^2 + y_1^2 + \dots + y_n^2$$

and  $S^{1,n}$  denote the quadric  $\{v \in V : Q(v) = -1\}$ .  $Q|S^{1,n}$  is a nondegenerate complete metric of type (1,n) and constant curvature -1 (cf. [14], [23]). Let  $\widetilde{S^{1,n}}$  be the universal covering of  $S^{1,n}$  equipped with the metric induced from that of  $S^{1,n}$ .  $\widetilde{S}^{1,n}$  is a simply connected complete pseudo Riemannian manifold of type (1,n)and constant curvature -1. (It is written  $H_1^{n+1}$  in Wolf's book.) Then the complete pseudo Riemannian manifolds of type (1,n) and constant curvature -1 are just the quotients  $\pi \setminus \widetilde{S^{1,n}}$  where  $\pi$  is a group of isometries that act freely and properly discontinuously. By a Lorentz space form we shall mean such a pseudo Riemannian manifold throughout this paper. According to Kulkarni [14], Lorentz space forms contain the set of strict space forms  $\{\Gamma \setminus S^{1,n}: \Gamma \subset O(2,n)\}$ , and the set of standard space forms  $\{\Gamma \setminus S^{1,2n}: \Gamma \subset U(1,n)\}$ , where O(2,n) (respectively U(1,n)) is the full group of Q-orthogonal (respectively unitary) transformations so that  $U(1,n) \subset O(2,2n)$ . When a Lorentz space form  $\pi \setminus \widetilde{S^{1,n}}$  supports a certain S<sup>1</sup> action, we observe in §1 that there exists a simply connected complete Riemannian manifold of sectional curvature  $\leq -1$  on which  $\pi/\mathbb{Z}$  acts properly discontinuously by isometries, where **Z** is an infinite central subgroup of  $\pi$ . Then we may use the result of visibility manifolds (cf. [8], [4]) to characterize  $\pi/\mathbb{Z}$ . As an application when  $\pi \setminus \widetilde{S}^{1,2n}$  is a standard space form, it is shown in §2 that  $\pi/\mathbf{Z}$  is uniquely determined by an amenable Lie group in U(1,n). An amenable Lie group is an extension of a solvable group by a compact group (cf. [9], [17]). In this case G is the semidirect product  $(\mathbf{R} \times \mathbf{C}^{n-1}) \circ (U(n-1) \times \mathbf{C}^*)$ .

**Theorem 2.9.** Let  $\Gamma \setminus S^{1,2n}$  be a standard space form. If  $\Gamma$  contains a nontrivial normal solvable subgroup, then it is isometric to  $g\Gamma g^{-1} \setminus G/U(n-1)$  for some  $g \in U(1,n)$ . In that case,
